Travis County Emergency Services District No. 2 ("District"), a political subdivision of the State of Texas operating under Chapter 775, Texas Health & Safety Code, providing fire and other emergency services to its citizens in Travis County. The District is circulating this *Request for Qualifications* ("*RFQ*") pursuant to Chapter 2254, Texas Government Code, the Professional Services Procurement Act, to potential respondents for architectural services related to the building of a 11,000 square-foot Fire Station ("Station") in Pflugerville, Texas. The award of any contract pursuant to this *RFQ* shall be on the basis of demonstrated competence and qualifications to perform architectural and related services to the District through all phases of the design and construction of the Station, pursuant to Section 2254.003, Texas Government Code, and other applicable law. The District initially prefers the Construction Manager Agent Method or the Construction Manager At-Risk Method under Chapter 2269, Texas Government Code, but will entertain other methods as may be recommended by the retained architect.

At a minimum, individuals or entities providing their qualifications shall have the following:

- 1. Licensed in the State of Texas to provide architectural services to the public for a minimum of 5 years;
- 2. Demonstrated competence and qualifications in all phases of the design, remodeling, construction, or other improvements to an emergency services station or other commercial project acceptable to the District, including construction supervision and related services and as a possible design-build representative for the District for the duration of the project;
- 3. Capability to perform the required services for the project;
- 4. Experience on similar projects;
- 5. Reputation, integrity, and competency of primary architect and firm;
- 6. Qualifications and experience of individual and/or firm.
